The COT started work on 19Oct2011 in the Miller Peak Wilderness Area at Miller Canyon, Huachuca Mountains by building a road on Forest Trail 106 with a John Deere 270D LC Track Hoe and a D6 size Dozer. By the afternoon they were digging in Miller Creek at their Miller Spring Location.

The Finally result was a 20 foot wide, 8 foot high, 245 foot long Embankment that contains a Catch Basin for the COT Pipeline. The embankment was built of material taken from the Creek, South side Slope and the Historic Reservoir Embankment. Also the main Miller Creek was channeled, terraced and straightened with the former Waterfall and Pool covered with soil. Lots of live trees were taken out, of which some were roosting trees for the Spotted Owl.

They also went, with the Track Hoe and Dozer, 250 feet on the South side of Miller Creek beyond the Miller Springs area, but were stopped by US Forest Service Law Enforcement.

After several days the COT was allowed to work only at Miller Springs. See Attached Authorization that states they must rehab the 250 feet above the Miller Springs Area.

Last week they finished with the main work at Miller Springs and are still going there for what I don I know. I see a need to go back if/when major flooding occurs, The COT City Manager stated that it took 4 years to get the Pipeline in Operation after the 1977 Carr fire and the Monument Fire Floodings is much worse.

The size of the dike/embankment is not what you would think the USFS would allow in a Wilderness Area.

Also the Catch Basin is a Death Trap for Wildlife. There was a waterfall and pool that was used by wildlife, but that is now covered by soil. The Catch Basin will catch most of the water, so Miller Creek will be dry most of the time.

Presently they are work on Beatty s Guest Ranch Property, downhill about a half mile, trying to put in 65 feet of pipeline, Another COT unauthorized work in the Miller Creek and Marshall Canyon Junction.
